**This position reports to the Manager of Ambulatory Care, Adult Diabetes Education Centre (ADEC) at WRHN Midtown. The successful candidate will provide effective inpatient focused diabetes education and clinical monitoring within the inpatient setting. In addition, the successful candidate will provide educational support to outpatient ADEC patients who require diabetes education and management.**

Goals to:

- Improve inpatient diabetes management and glycemic control.
- Enhance patient education and confidence in self-management prior to discharge.
- Decrease delays in discharge and overall inpatient length of stay.
- Reduce emergency department visits and readmissions related to poor diabetes control.
- Strengthen coordination between inpatient, outpatient, and community care at the time of discharge by facilitating rapid follow-up in the Adult ADEC and/or Endocrinologist clinic, where appropriate

**QUALIFICATIONS:**

- Baccalaureate preparation in nursing preferred
- Current Certification of Competence with the College of Nurses of Ontario.
- Certification as a Diabetes Educator required.
- Experience with insulin pump management required.
- Minimum five years recent experience in diabetes management and education including knowledge of theoretical principles of adult learning and change theory.
- Demonstrated skills in facilitating groups, team skills and effective communication.
- Demonstrated ability to work autonomously and as a member of
